We are seeking bright, enthusiastic young leaders to help us extend our mission to educate, hands-on and gloves-off!

This role is ideal for students who are motivated to both develop their leadership skills and mentor younger students, as well as to connect with an international group of young people who are passionate about global issues and motivated to make a change in the world. This is an opportunity to help others grow while also learning yourself!

## Privileges of a Model G20 Ambassador

Ambassadors receive benefits beyond the reach of other Model G20 students:

- 1. You will qualify for a seat in the Model G20 Summit's Deciding Committee,\* a leadership group tasked with creating grading rubrics and evaluating the performance of Delegates.
- 2. You will earn a tuition waiver for your current summit experience, or for a future one.
- 3. You will receive official recognition for your leadership in the form of a certificate, to include on your résumé (and on your trophy shelf).

#### Criteria to Become a Model G20 Ambassador

To demonstrate your commitment and your influence in your community:

- Refer 3 students and you'll automatically become an ambassador, given all the benefits of ambassadorship.
- Refer 8 students and you'll receive all the benefits of ambassadorship, as well as a tuition waiver for your current or next summit.

### \*The Deciding Committee

The members of the Deciding Committee will play the role of a senior leader of a prominent international organization, such as the World Bank Group or the United Nations. They are responsible for evaluating the final presentations based on a rubric they will, in part, develop.

Members of the Deciding Committee will need to consider the priorities of the organization they represent when developing the rubric, as well as when communicating with Delegates. They will serve as program ambassadors by assisting the senior leadership of the Summit with managing meetings and communicating with Delegates.

As a member of the Deciding Committee, you will have the authority of a leadership role at the Summit. This authority is a great privilege, and the role requires young people who are mature, thoughtful, and eager for the responsibility of ensuring a successful Summit.



#### The responsibilities of the Deciding Committee include:

- Acting as a dedicated mentor and resource for several country delegations, which includes assisting with questions during the program and providing feedback on ideas.
- Leading the Delegates' Ministerial Meetings most relevant to their organization.
- Attending Country Round Table Meetings as both an observer and a mentor, providing guidance and answering questions when Delegates require it.
- Reviewing the rubric that will be used to evaluate the final presentations, and creating additional criteria to assess qualities they believe are most important for the Delegates to demonstrate.
- Leading the Discussion with Advisory session, where they will provide in-depth feedback and support to several Country Delegations before the final presentations.
- Demonstrating leadership, passion, and a high level of engagement throughout the program.
- Demonstrating an interest in and knowledge of climate science, policy, and politics in order to fully evaluate the final presentations.
